I/we \_\_\_\_\_ referred to herein as Client/Driver(s), Agree to rent the specified Race Car from Zook's Aviation Services Inc. (Racing), herein referred to ZASR, for the competition event held at \_\_\_\_\_ on \_\_\_\_\_, sanctioned by \_\_\_\_\_.

By signing this agreement, the Client/Driver(s) agrees that automobile racing is a dangerous sport. By participating in a competition event, the Client(s) agrees that injury and even death may result from an accident during the event. By driving the vehicle onto the course of competition, the renter agrees that the vehicle is safe for driving and competing in the racing event.

By signing this agreement, the Client(s) agrees that all members of the Clients' Family have been notified of the intentions to drive a competition vehicle in a competition event, and the client and the family members agree to absolve ZASR, its agents, employees, and any officials from any liability through the use of this racing vehicle.

Safety is the highest concern, ZASR will provide the race car at the track facility in race ready condition. The race car will have passed an SCCA/EMRA annual technical and safety inspection which will be noted in the Log Book.

Each Client is totally responsible for any damages to the racecar that occur while in control of racecar, irregardless of fault. Any damages other than normal wear and tear will be repaired by ZASR or mechanic /working for or designate by ZASR. If the race car is unable to continue due to the fault of ZASR, a refund will be issued pro-rated for actual time driven. If the racecar is damaged on course and is unable to continue, ZASR will retain the full rental fee. In the event any damage or problems occur to the race car, making it unsafe, the vehicle's ability to continue in the event are at the sole discretion of ZASR or Owner of subleased/rented car.

\*\*A crash deposit of \$2,500 will be collected from the Client (s) prior to or at the track before the racecar is driven onto the competition course. (If this is a shared rental for an Endurance Event and it is a sub lease of another owners car, then the crash deposit shall be shared between all drivers registered to drive the car for the event.) If there is no damage to the racecar at the conclusion of the event, the entire deposit will be returned to the Client/Driver(s) before parties leave the racing facility. In the event of damaged, the deposit will be retained be ZASR or Owner of subleased/rented car until the damages are repaired, if repairs are less than the deposit, a refund will be mailed to the Client/Driver(s). If this is a shared deposit, the driver that incurs the damage will pay the crash damage out of the deposit and reimburse the drivers for their share of their unused crash deposit that they initially made to secure getting the car on the track.

If damages exceed the deposit an invoice will be sent with the total for damages less the deposit. All payments are due upon receipt of invoice. Any dispute arising from the use of the racecar, this contract or service provided, will be settled in County of Volucia, State of Florida or Duches County, State of New York dependent on the part of the country the event is held.

The rental fee for the above \_\_\_\_\_ day(s) event will be \$ \_\_\_\_\_. A deposit of \$250 will be required to secure the racecar for the specified event. This deposit is non-refundable unless we are notified 2 weeks in advance and are able to secure another Client, the deposit will be retained to cover the cost of preparation done on the vehicle. Florida Sales tax of 6% and N.Y. Sales tax of 7.5% will apply for events occurring in the respective states.
